STOCKHOLDER COMMUNICATIONS POLICY

1. PURPOSE

LIFE360, INC. (the “*Company*”) is committed to regularly communicating with stockholders in a timely, accessible and clear manner with respect to both procedural matters and major issues affecting the Company. To achieve this, the Company communicates with stockholders through a range of forums and publications. The reference to "stockholder" in this Policy includes holders of shares of common stock, CHESS Depository Interests (“CDIs”), options, restricted stock units and other securities of the Company.

2. COMPANY WEBSITE

The Company aims to provide stockholders with comprehensive and timely access to Company documents and releases through its website.

The Company's website will include:

- copies of the Company's bylaws, certificate of incorporation, Board and committee charters and key corporate governance policies;
- copies of all material information lodged with the U.S. Securities and Exchange Commission and the Australian Securities Exchange and any other applicable securities regulators and securities exchanges;
- copies of all announcements, briefings and speeches made to the market, analysts or the media;
- press releases or announcements made by the Company;
- financial data for the Company;
- appropriate contact information for stockholders to submit enquiries directly to the Company;
- the full text of notices of stockholder meetings and explanatory material;
- the names, photographs and brief biographical information for each of the Company's directors and senior executives;
- webcasts (as and when available);
- presentations provided to financial analysts; and
- advanced notice of all open briefings to institutional investors and analysts, including presentation materials.

Other information and updates may be provided to stockholders via periodic mail-outs. In addition, the Company allows stockholders to elect to receive email communications where appropriate.

3. COMMUNICATIONS TO NON-MANAGEMENT DIRECTORS

In cases where stockholders wish to communicate directly with our non-management directors, messages can be sent to the Company's General Counsel at legal@life360.com.

Each communication should set forth (i) the name and address of the stockholder, as it appears on the Company's books, and if the Company's common stock is held by a nominee, the name and address of the beneficial owner of the Company's common stock, and (ii) the number of shares of the Company's common stock that are owned of record by the record holder and beneficially by the beneficial owner.

Our General Counsel, in consultation with appropriate directors as necessary, will review all incoming stockholder communications (except for mass mailings, product complaints or inquiries, job inquiries, business solicitations and patently offensive or otherwise inappropriate material). If appropriate, our General Counsel will route such communications to the appropriate director(s) or, if none is specified, to the Chairperson of the Nominating and Corporate Governance Committee of the Board (the "*Nominating Committee*") after review by the General Counsel.

Our General Counsel may decide in the exercise of their judgment whether a response to any stockholder communication is necessary and will periodically report to the Nominating Committee regarding any stockholder communications received to which the General Counsel has responded.
