Also includes 4,947 restricted stock units, each of which represents a contingent right to receive one share of the Issuer's common stock upon vesting.
- 2. The stock option is fully vested and exercisable.
- 3. The stock option vests and becomes exercisable as to 1/4th of the total number of shares in equal quarterly installments beginning on August 15, 2022, until such time as the option is 100% vested, subject to the continuing service of the Reporting Person on each vesting date.
