The number of shares reflects a pro rata portion of the standard annual committee retainer grant. Each RSU represents a contingent right to receive one share of the Issuer's common stock upon settlement. One-third (1/3) of the RSUs will vest on each of November 15, 2026, February 25, 2027, and May 15, 2027, subject to Mr. Prober's continuous service through each vest date.

2. Includes 4,474 RSUs previously granted, each of which represents a contingent right to receive one share of the Issuer's common stock upon vesting.
