The CDIs are traded on the Australian Securities Exchange (the "ASX") and are held by CHESS Depository Nominees Pty, Limited, a subsidiary of ASX Limited, the company that operates the ASX. Also includes 82,926 restricted stock units, each of which represents a contingent right to receive one share of the Issuer's common stock upon vesting.
- Represents shares of the Issuer's common stock underlying 89,880 CDIs.
- The Reporting Person is a member of ICCA Labs, LLC, an entity that holds an aggregate of 133,408 shares of the Issuer's common stock underlying 400,224 CDIs. The number of shares reported herein by the Reporting Person represents his proportionate ownership interest in ICCA Labs, LLC.
